### 2. Composition/information on ingredients:

EVA-copolymer / Synthetic resin / Wax and Stabilizer

### 3. Hazards identification:

Gases formed at high temperatures may irritate the eyes and the respiratory tract.

### 4. First aid measures:

## 5. Fire fighting measures:
